For example, Tariff Sheet No. 3.14, includes language which states that customers that sign up for automatic bill payment will receive a one-time \$5.00 credit on their telephone bills. While ACS-N continues to offer automatic bill pay to customers as a payment option, the company no longer offers a one-time \$5.00 credit. As shown on revised Tariff Sheet No. 3.14 language regarding the \$5.00 automatic bill payment credit has been deleted and replaced with the language that states that a customer may sign up for automatic bill payment.

In addition, the existing tariff includes two sections that discuss the filing and disposition of customer complaints (see Sections 3.2.7.6 and 3.2.11). The provisions in each of these sections includes identical language that is duplicative and unnecessary. Therefore, the language included in Section 3.2.7.6 has been deleted.
